



## Lake Wallenpaupack Watershed Management District Agricultural Improvement Cost-Share Program

The LWWMD is currently accepting applications for agricultural improvement projects within the Lake Wallenpaupack Watershed. Agricultural operations must fall under the requirements of the "PA Right to Farm Law". Grants will be made available for a 50% match of eligible project costs up to a maximum of \$15,000. (For example-If your project costs \$30,000 the LWWMD will provide up to a \$15,000 match.) Priority will be given to projects that reduce or eliminate the flow of pollutants into Lake Wallenpaupack, and those that provide greater than 50% landowner match.
